### Brief summary of reported paranormal activity at this location

All residents have seen a well dressed man in the upstairs particularly in the bedroom areas. All residents have also seen a smaller figure of light (a girl?) traveling throughout the upstairs kitchen and basement living room areas. No attempts of contact have been made by either entity.

Several times while sitting in the home it would sound like something got thrown through a window and hit the wall on the opposite side of the room. In each case no object was ever found and the windows were always closed even though the curtains would move like something did come through them. Footsteps are heard all the time. When upstairs you will hear the sounds of weight lifting equipment and the pool table being used in the basement living area. Orbs are sometimes caught in pictures taken inside the home. The home owner keeps having a reoccurring nightmare that he isn't able to remember once woken up.

### OPERATIONAL INSTRUCTIONS:

- Arrival on site 7:15 PM for 7:30 start.
- Upon arrival client will provide brief summary of activity in the Living Room area of the home. The first floor is small. We will be establishing our contact area in the living room but will also investigate there.
- Plan on two rotations of 60-90 minutes in length.
- The first 10 minutes of each rotation will be a "vigil" (no movement, talking or "radio chatter")
- Video Cameras will be set up on both the first fl. and basement fl. Additional cameras if available will remain with the investigator.
- Radios will utilize Channel 6 as the primary and Channel 7 as the alternate.

All together we analyzed around 700 mins of camcorder audio and video both. We also analyzed around five hrs. of digital audio recordings. Unfortunately from all of this footage we found no evidence that we could unequivocally say was paranormal. While using our ghost box we did seem to get some direct answers to questions that where asked at the time however the recording of that session could not be found at the time of evidence review? Personally, I had an experience during that recording session where I felt the presence of someone in my personal space, back and to the right of me, and at the same time felt/heard a breath in my ear. This was totally unexplainable. There was a lack of evp/paracoder activity through the evening. From the 400+ pictures that where taken some had orbs, one has some sort of anomaly in our laser grid, and another in the kitchen has other abnormalities it. All of these will be presented as possible evidence during the reveal. It is our professional opinion that although we can not say inconclusively that the home is haunted from a direct evidence viewpoint, we do think that the abnormalities are interesting and would like to reserve the right to come investigate at some point in the future.
